- 1. - 2. That on the 15th day of February, 2023, said purchasing officer advertised for bid metal pipe by placing a legal notice in The Baxter Bulletin, a newspaper having general circulation in Baxter County, Arkansas. The notice of publication and a copy of said specifications are hereto attached as Exhibits A and B respectively.
- 3. On March 13, 2023, Metal Culverts, Inc. Sales delivered or caused to be delivered their bids at the time and place appointed in the bid notice. No other bids were submitted.
- 4. At 10:00 a.m. on the 14th day of March, 2023, said bids were opened and publicly read in the office of the County Judge. Metal Culverts, Inc. submitted a bid as shown by Exhibit C.
- It was determined to be in the best interest of Baxter County to accept the bid from Metal Culverts, Inc. A copy of the bid acceptance is hereto attached as Exhibit D.

IT IS THEREFORE the order of this Court that the bid from Metal Culverts, Inc. is hereby approved and accepted and the Clerk of this Court shall docket this copy and cause a copy of this order and supporting documents to remain on file for public inspection.




