
COURT ORDER NO. 2023 - 24

NOW on this 14th day of March, 2023, a day on which this Court deems to be in session, come on for consideration the purchase of 1/2 inch chips to be used by the Baxter County Road & Bridge Department. From the records of said solicitations of bids the Court finds the following:

1. That all potential bidders, engaged in the selling of 1/2 in chips who have applied in the office of the County Judge, an ex-officio purchasing official for Baxter County, stating a desire to be placed on a list of eligible bidders in that class of commodities, have been supplied with ample specifications.
2. That on the 15th day of February, 2023, said purchasing officer advertised for bid the purchase 1/2 inch chips by placing a legal notice in The Baxter Bulletin, a newspaper having general circulation in Baxter County, Arkansas. The notice of publication and a copy of said specifications are hereto attached as Exhibits A and B respectively.
3. On March 13, 202, White River Material's Inc. and North Central Arkansas Quarry, Inc. delivered or caused to be delivered their bid at the time and place appointed in the bid notice. No other bids were received.
4. At 10:00 a.m. on the 14th day of March, 2023, said bids were opened and publicly read in the office of the County Judge. The bid submitted by White River Material's Inc. is hereto attached as Exhibit C and the bid submitted by North Central Arkansas Quarry, Inc. is hereto attached as Exhibit D.
5. It was determined to be in the best interest of Baxter County to accept the bids from North Central Arkansas Quarry, Inc. and White River Material's Inc. Copy of bid acceptance are hereto attached as Exhibit E and Exhibit F.

IT IS THEREFORE the order of this Court that the bid from North Central Arkansas Quarry, Inc. is hereby approved and accepted. The Clerk of this Court shall docket this copy and cause a copy of this order and supporting documents to remain on file for public inspection.

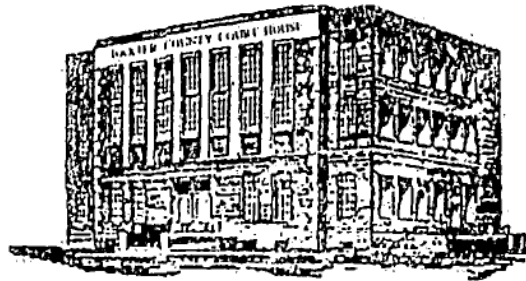

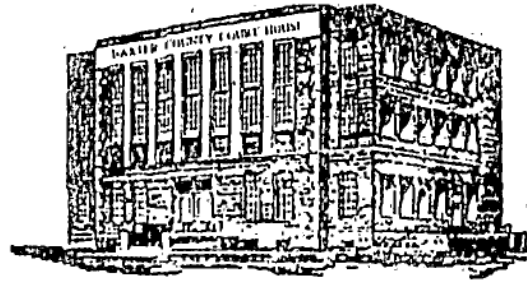

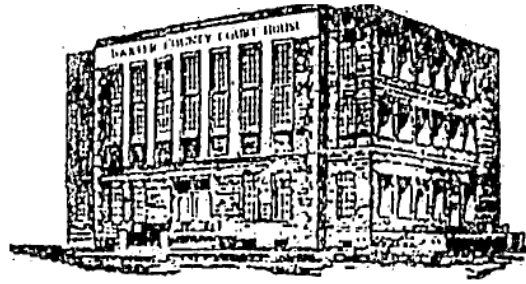
