COURT ORDER NO. 2023-6

NOW on this 1st day of February, 2023, a day on which this Court deems to be in session, come on for consideration the purchase of two 2023 Super Cab Pickups to be used by the Baxter County Coroner's Office. From the records of said solicitations of bids the Court finds the following:

1. That all potential bidders, engaged in the selling of 2023 Super Cab Pickups who have applied in the office of the County Judge, an ex-officio purchasing official for Baxter County, stating a desire to be placed on a list of eligible bidders in that class of commodities, have been supplied with ample specifications.
2. That on January 18, 2023, and January 25, 2023, said purchasing officer advertised for bid the purchase two 2023 Super Cab Pickups by placing a legal notice in The Baxter Bulletin, a newspaper having general circulation in Baxter County, Arkansas. The notice of publication and a copy of said specifications are hereto attached as Exhibits A and B respectively.
3. On January 30, 2023, Freedom Ford and Ultimate Auto Group delivered or caused to be delivered their bid at the time and place appointed in the bid notice. No other bids were received.
4. At 10:00 a.m. on the 1st day of February, 2023, said bid was opened and publicly read in the office of the County Judge. The bid submitted by Freedom Ford is hereto attached as Exhibit C and the bid submitted by Ultimate Auto Group is hereto attached as Exhibit D.
5. It was determined to be in the best interest of Baxter County to accept the bid from Ultimate Auto Group. Copy of bid acceptance is hereto attached as Exhibit E.

IT IS THEREFORE the order of this Court that the bid from Ultimate Auto Group is hereby approved and accepted. The Clerk of this Court shall docket this copy and cause a copy of this order and supporting documents to remain on file for public inspection.

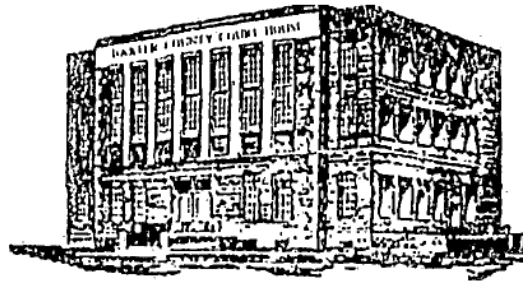

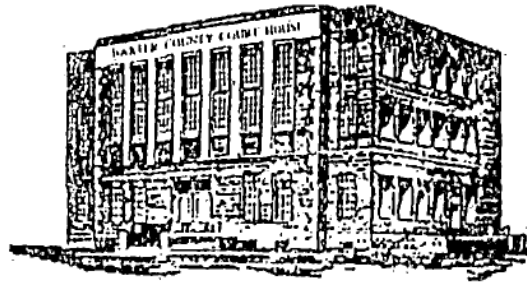
