

APPROPRIATION ORDINANCE NO. 2023 - 11

BE IT ENACTED BY THE QUORUM COURT OF BAXTER COUNTY, STATE OF ARKANSAS,  
AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE APPROVING THE FUNDING OF A FULL-TIME SECRETARY POSITION IN  
THE PUBLIC DEFENDER'S OFFICE FOR THE YEAR 2023.

**Article 1: Affirmation.** The Baxter County Budget Committee approved a request made by Public Defender Dan Hancock to fund a Full-time Secretary position in the Public Defender's Office for the year 2023. The funding for the Full-time Secretary Position for the year 2023 will be split between the Public Defender's Fund (#3024) and County General Fund (#1000).

The funding for a Full-time Secretary position for the year 2023 in the Public Defender's Office is hereby approved.

**Article 2: Appropriation.** The Baxter County Quorum Court authorizes the IT Manager to make the following changes and appropriations within the Public Defender's 2023 Budget.

- \$15,702.14 to GL #1000-0417-1001 (Full-time Salaries)
- \$ 1,201.22 to GL #1000-0417-1006 (Social Security)
- \$ 2,405.57 to GL #1000-0417-1007 (Retirement)
- \$ 2,610.00 to GL #1000-0417-1009 (Health Insurance)
- \$ 14.13 to GL #1000-0417-1010 (Work Comp)
- \$ 25.13 to GL #1000-0417-1011 (Unemployment Comp)

Total \$42,773.76 to be appropriated.

**Article 3: Effective Date.** This appropriation ordinance shall be effective immediately upon its passage by the Quorum Court.
