

APPROPRIATION ORDINANCE NO. 2023 - 12

BE IT ENACTED BY THE QUORUM COURT OF BAXTER COUNTY, STATE OF ARKANSAS,  
AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE APPROVING THE FUNDING OF A TEMPORARY FULL-TIME DEPUTY II  
ASSESSOR POSITION IN THE ASSESSOR'S OFFICE.

**Article 1: Affirmation.** The Baxter County Budget Committee approved a request made by Assessor Jayme Nicholson to fund a Temporary Full-time Deputy II Assessor Position in the Assessor's Office. The Temporary Full-time Deputy II Assessor Position will be funded for the remainder of 2023 from funds available in the County Assessor's 2023 Part-time Salaries line item and County General Fund (#1000).

The funding of a Temporary Full-time Deputy II Assessor position in the Assessor's Office is hereby approved.

**Article 2: Appropriation.** The Baxter County Quorum Court authorizes the IT Manager to make the following changes and appropriations within the Assessor's 2023 Budget.

\$15,000.00 from GL #1000-0105-1002 (PT Salaries) to GL #1000-0105-1001 (FT Salaries)

\$22,305.60 to GL #1000-0105-1001 (Full-time Salaries)  
\$ 2,853.88 to GL #1000-0105-1006 (Social Security)  
\$ 5,715.22 to GL #1000-0105-1007 (Retirement)  
\$ 5,220.00 to GL #1000-0105-1009 (Health Insurance)  
\$ 455.13 to GL #1000-0105-1010 (Work Comp)  
\$ 59.69 to GL #1000-0105-1011 (Unemployment Comp)

Total \$51,609.52 to be appropriated.

**Article 3: Effective Date.** This appropriation ordinance shall be effective immediately upon its passage by the Quorum Court.
