**COURT ORDER NO. 2024 - 15**

NOW on this 20th day of February, 2024, a day on which this Court deems to be in session, come on for consideration the purchase of Brown Chips / Pea Gravel Mix to be used by the Baxter County Road & Bridge Department. From the records of said solicitations of bids the Court finds the following:

1. That all potential bidders, engaged in the selling of Brown Chips / Pea Gravel Mix who have applied in the office of the County Judge, an ex-officio purchasing official for Baxter County, stating a desire to be placed on a list of eligible bidders in that class of commodities, have been supplied with ample specifications.
  2. That on the 17th day of January, 2024, said purchasing officer advertised for bid the purchase Brown Chips / Pea Gravel Mix by placing a legal notice in The Baxter Bulletin, a newspaper having general circulation in Baxter County, Arkansas. The notice of publication and a copy of said specifications are hereto attached as Exhibits A and B respectively.
  3. On February 16, 2024, MC Materials, LLC and Mountain Home Materials delivered or caused to be delivered their bid at the time and place appointed in the bid notice. No other bids were received.
  4. At 10:00 a.m. on the 20th day of February, 2024, said bids were opened and publicly read in the office of the County Judge. The bid submitted by MC Materials LLC is hereto attached as Exhibit C. The bid submitted by Mountain Home Materials is hereto attached as Exhibit D.
  5. It was determined to be in the best interest of Baxter County to accept the bid from MC Materials LLC. Copy of bid acceptance is hereto attached as Exhibit E.
- IT IS THEREFORE the order of this Court that the bid from North Central Arkansas Quarry, Inc. is hereby approved and accepted. The Clerk of this Court shall docket this copy and cause a copy of this order and supporting documents to remain on file for public inspection.

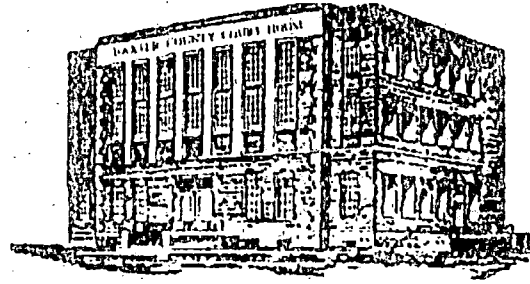

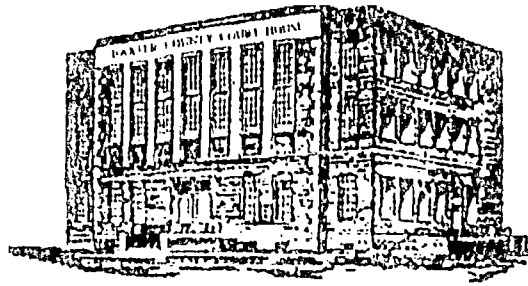
