If you all recall, we had two big ticket items in the jail, Control Board and Radio Consoles. We budgeted them for the 2025 budget. There was a lot of discussion last fall as to which line item to put the \$455,000 in,

and ultimately, we budgeted it in the 4003 Improvements other than building line item.

We have paid for two invoices, one in January and one in February, \$82,000 each to ECC from that line item.

After much discussion with the Clerk's Office, Canda and I have determined that the money should have been placed into the 3401.0418.4004, Machinery and Equipment line item. Trish, can you have the Judge issue a County Court Order moving \$455,000 from 3401.0418.4003, Improvements other than Buildings, to 3401.0418.4004, Machinery and Equipment.

And Canda, can you have your office do a journal entry for the two invoices to ECC in January and February reflecting the change to the new line item.
