

APPROPRIATION ORDINANCE NO. 2025 - 50

BE IT ENACTED BY THE QUORUM COURT OF BAXTER COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE APPROPRIATING FUNDS IN THE AMOUNT OF \$23,000.00 FROM SPECIAL JAIL FEES FUND (3017) AND \$6,000.00 FROM COUNTY DETENTION FACILITY FUND (3018) INTO THE JAIL MAINTENANCE & OPERATION FUND (3401) 2025 BUDGET.

Article 1. Affirmation: The Sheriff's Office is requesting an allocation of funds within the 2025 budget for the purpose of appropriate assignment of expenditures.

Article 2. Designation: There are sufficient funds available for said transfers.

Article 3. Appropriation: The County Treasurer is authorized to transfer \$23,000.00 from Special Jail Fees Fund (3017) and \$6,000.00 from County Detention Facility Fund (3018) into the Jail Maintenance & Operation Fund (3401).

The Quorum Court authorizes the Clerk's Office to make the following appropriations into the designated line items:

\$ 3,000.00 from Special Jail Fees Fund #3017 to GL #3401-0418-3003 (Computer Services)

\$15,000.00 from Special Jail Fees Fund #3017 to GL #3401-0418-3009 (Other Prof Srvs)

\$ 2,000.00 from Special Jail Fees Fund #3017 to GL #3401-0418-3020 (Telephone and Fax)

\$ 3,000.00 from Special Jail Fees Fund #3017 to GL #3401-0418-3402 (Water)

\$ 6,000.00 from Detention Facility Fund #3018 to GL #3401-0418-2006 (Clothing and Uniforms)

Article 4. Effective Date: This appropriation ordinance shall be effective immediately upon its passage by the quorum court.
