Now on this 19th day of August, 2025, comes on or before the Court the above-styled Petition and from all things presented to the Court and from the testimony of the witnesses herein, the Court doth find as follows:

- 1. That the Petitioner herein, Tammy L Shelly Owner of Carpet Factory, has overpaid Personal Property Taxes on the above-referenced property to Baxter County, Arkansas, for the following reason: the petitioner had been turning in their numbers on their business assessment as if they were a manufacturer and not a retail store for the 2022 and 2023 tax years.
