
IN THE MATTER OF REALLOCATING OUTSTANDING CHECKS THAT HAVE  
NOT BEEN CASHED AND ARE OVER 6 MONTHS OLD.

COURT ORDER NO. 2025 - 78

NOW on this 29th day of September, 2025, a day on which this Court deems to be in session, comes on for consideration the reallocation of monies from outstanding checks that have not been cashed and are over 6 months old. From the records before this Court, the Court finds the following:

1. That six (6) checks, totaling \$146.60, written in 2025 remain outstanding and are now considered non-negotiable (*see attached*); and
2. That these checks were to be expensed from the County General Fund (#1000)
3. It is necessary for these monies to be reallocated back into the account from where they were to be expensed.

NOW, THEREFORE, be it ordained that the Baxter County Court hereby authorizes the County Treasurer to reallocate the amount of \$146.60 to the County General Fund (#1000). The Clerk of this Court shall docket this copy and keep a copy of this order and supporting documentation on file for public inspection.

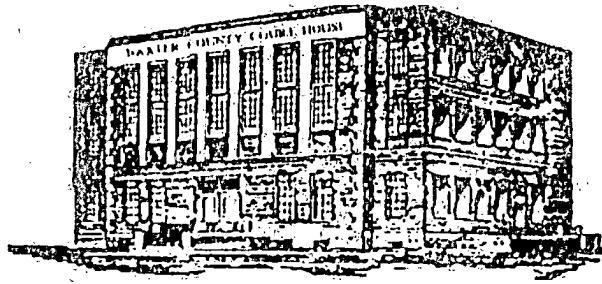
