

ORDINANCE NO. 2026 - 12

BE IT ENACTED BY THE QUORUM COURT OF BAXTER COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO REPEAL ORDINANCE 2025-60 "AN ORDINANCE ACCEPTING THE INTERLOCAL AGREEMENT BETWEEN BAXTER COUNTY AND THE CITY OF MOUNTAIN HOME FOR THE PURPOSE OF DISBURSEMENT OF DISTRICT COURT ACCOUNTING RECORDS AND SUPPORT OF COUNTY-LEVEL PROGRAMMING; AND TO DECLARE AN EMERGENCY."

Article 1: Affirmation. Baxter County and the City of Mountain Home previously entered an Interlocal Agreement pursuant to Arkansas Code Annotated § 14-14-910 for the purpose of coordinating the disbursement of district court accounting records and supporting county-level programming; and

Section 1. Baxter County Quorum Court approved said Interlocal Agreement by Ordinance No. 2025-60 on December 1, 2025; and

Section 2. New information has been obtained regarding the statutory requirements for the disbursement of collected second-class district court accounting records, indicating that the City of Mountain Home is no longer involved in or responsible for these disbursements; and

Section 3. The continued existence of the Interlocal Agreement is unnecessary and no longer serves an operational or legal purpose for Baxter County; and

Section 4. It is in the best interest of Baxter County to repeal Ordinance No. 2025-60.

Article 2: Appropriation. The Interlocal Agreement authorized by Ordinance No. 2025-60 is hereby terminated. Baxter County shall provide written notice of this termination to the City of Mountain Home in accordance with the terms of the agreement and Arkansas Law.

Article 3: Emergency Clause. It is hereby found and determined that the continued existence of the Interlocal Agreement creates administrative confusion and serves no current legal purpose; therefore, an emergency is declared to exist, and this ordinance shall be in full force and effect immediately upon passage.
