Article 1: <u>Affirmation.</u> The Baxter County Quorum Court finds it necessary to require all Baxter County Employees to be paid by Electronic Warrants Transfer (Direct Deposit) system directly into the payees' accounts in financial institutions.

<u>Section 1.</u> Effective January 1, 2025, all Baxter County Employees shall be required to accept payment of salary or wages by electronic warrants transfer. The electronic warrants transfer shall be made in the form of a direct deposit of funds to the account of the beneficiary of such payment in any financial institution equipped for electronic fund transfers, provided that such financial institution is designated in writing by such beneficiary and has lawful authority to accept such deposits. The employee must make note that the entire check will be deposited into the account(s) he/she specifies.

<u>Section 2:</u> The Baxter County Quorum Court authorizes the use of internet banking by the County Treasurer's Office to conduct the county's financial business.

Article 2: Effective Date. This ordinance shall be effective immediately upon its passage and approval by the Quorum Court.

Article 1: Affirmation. It has been determined by the Baxter County Personnel Committee that revisions and additions in the Baxter County Personnel Policy and the Baxter County Sheriff's Office Policy manuals are necessary to improve the overall effectiveness and efficiency of Baxter County Government.
